### Terms and conditions as pension funds

- Cost advantage of more than 1% p.a. depending on the fund

### Investment risks minimized

- Broad diversification: The single-security risk is minimized by consistent diversification across a large number of companies.
- Long investment horizon: Every investment in equities is exposed to market fluctuations that are reduced over a long-term investment horizon.
- In addition for offers with regular premiums: By making regular payments, you can benefit from low purchase prices when equity prices fall (average cost method).
